Bruce distributed Statement of Cash Flows and Profit and Loss Budget vs. Actual as of 04/06.

Lottery. Would like to accept 55 new students; 46 students have already accepted. If all students stay, the total student body count is 310. There are 20 students remaining on the waitlist.

Testing. ASD cancelled testing for this year due to a severed fiber optic cable in the lower 48.

Event Planning. Staff proposes a change in the way school-wide events will be planned. The new proposal is "Grade-level class activities are reduced to information dissemination, and all school-level events are planned by committees generated through the school government, Op Group". This allows anyone from the Steller community to participate in the planning of any school-wide events. Comment about how to engage students who may not be as naturally outgoing and participatory. Comment about how to maintain class identity when there aren't many other opportunities for that. Removes the stress related to fundraising for individual events. Comment to keep the learning opportunity of increased financial responsibility as students progress through grade levels at Steller.

MOTION: Parent group recommends support of this proposal.

All in favor. Motion approved.

Overnighter. Staff proposes a change to the overnight event. The new proposal is "An all-night Activity Night will no longer be a sanctioned Steller event". Staff recommends replacing this with an equivalent event. A possible alternative is to spend the same amount of time with similar activities going from after school to midnight. Or to hand over the planning and execution of this event to a group of parents to be held off site. Staff hopes that Parent Group and Op Group will take on the alternative event planning. Comment about extending just beyond midnight. Comment about students concerned over parents not willing to pick students up in the middle of the night. Comment about holding an event at Alaska Club. Suggestion to discuss further at a future All-Community Meeting (at the beginning of next school year).
